Legal News

Derek's solicitor is currently having an independent report prepared; this will examine the strength and soundness of the forensic evidence against Derek.

Innocent

At the end of October Kevin and I attended a public meeting in Manchester hosted by the campaigning group Innocent. Both Innocent and its sister organisation conviction are supporting Derek's case. Innocent has played a major role in having several miscarriages of justice reversed, perhaps the most (in)famous of which has been the Kevin Callan case.

Among the guest speakers at the meeting were Michael O' Brien - one of the "Cardiff Newsagent Three" - who spent 11 years in prison before being released on bail pending the outcome of his appeal hearing in December, and Paddy Joe Hill - one of the "Birmingham Six" - who spent over 16 years in prison before his conviction for the Birmingham pub bombings was quashed in 1991.

Both Michael and Paddy spoke of the need to campaign vigorously on behalf of wrongfully convicted prisoners. As they both testified, the quest for the truth and justice can be a long and slow one.

Crimewatch File

The Broadcasting Standards Commission (BSC) has not upheld our complaint of unfairness against the BBC and its Crimewatch File programme which featured the investigation into the murder of Margaret Wilson.

While the BSC conceded the case was a complex one, it felt the programme showed how the police debated the complex issues in the investigation.

The BBC, in its evidence presented to the Commission, suggested that Derek had grown a "pronounced goatee beard" in the space of 3 days, and the BSC, as part of its adjudication, considered it of no significance that a clean-shaven actor was used to portray Derek in the programme. The BSC also accepted that reference to the complexity of the fibre evidence and to fibres not attributable to Derek might have been helpful [to putting Derek's case], but felt it was fair to present such complicated evidence in a simplified manner.

If Derek's story upsets you, write to your MP or Home Secretary Jack Straw, at the House of Commons, London, SW1A OAA, demanding that Derek's case be referred back to the Court of Appeal.
